SPECIAL OLYMPICS

Our Bank has maintained a strong partnership with the Special Olympics Nigeria (SONig) over the years to promote societal acceptance and all year physical training of individuals with intellectual disabilities.

In 2012, aside from our usual support for the National Olympics games, we had members of our staff volunteer during the competition in the following states; Enugu, Lagos, Imo, Abia, Osun, Ogun and Oyo States.

SWISS RED CROSS

The Swiss Red Cross is a humanitarian organization which provides an avenue

The bank actively participates in the Swiss Red Cross annual fund raising event. Funds raised are used to ensure continuation of efforts in the areas of healthcare, reconstruction and disaster relief and preparedness for the victims of Forgotten Disasters.

- The prevention of blindness by conducting eye examination and treatment in Ghana
- Provision of primary healthcare and safe drinking water in Sudan to 200,000 children and adults
- Provision of portable water and building of latrines to improve hygiene of the villages in Cambodia
- Prevention/cure of tuberculosis through access to treatment. Also, the provision of required vitamins and mineral supplements and improvement of healthcare to prevent malnourishment in Bolivia,

PLAYERS DEVELOPMENT PROGRAMME (CAMP GTBANK)

This a residential camp designed as a football talent development vehicle to identify, train and develop the next generation of Nigeria's football talents that emerge from the tournaments.

A total of 26 players (18 male, 8 female) were selected from the 2012 Principals cup and Heritage cup competitions to participate in the Camp. Mark Ellis, Youth Coach for Arsenal FC and Fulham FC was invited to Nigeria to coach the young players on series of trainings featuring formation, strategy, tactics, conditioning and physical exercises. He was assisted by our local coaches such as Yise Shofoluwe (Nigerian Male Coach) and Ms Anne Chiejine (Nigerian Female Coach). Officials of the Ministries of Education and Sports acted as chaperones and were present throughout the camping period.

Guaranty Trust Bank plc, being innovative has implemented Energy Efficiency Solutions as part of our contribution to mitigating the effect of climate change in our environment. We have invested in renewable energy and implemented resource efficient ways in conducting our businesses.

RENEWABLE ENERGY

Biogas Project-Waste To Energy

In order to promote a sustainable environment in our host community, our Bank partnered with the Students In Free Enterprise (SIFE) Nigeria on a Bio-gas project which involved the conversion of domestic waste to methane gas for domestic use. The pilot project which began at the University of Ado-Ekiti was taken to the University of Abuja and the Nnamdi Azikiwe University Akwa.

In 2012, the first prototype – pilot phase was deployed and used by a family in Ekiti State and received positive feedback. We intend to donate portable bio-gas plants to local communities within Ekiti state.

Solar Energy

In 2012, efforts were made to reduce our emissions; we currently use solar energy to power 35 GTBank e-branches and branches in different locations. This initiative is part of our efforts in transiting to a low carbon economy and it is also in line with the 2012 World Environment Day themed "Green Economy: Does it include You?".

RESOURCE EFFICIENCY

Electronic Channels

In 2012, we upgraded our electronic channels to ensure time and energy conservation. Customers were encouraged to adopt alternative channels such as Point of Sales (POS) terminals, Internet banking, Mobile Banking/GTMobile, Automated Teller Machines (ATMs) and e-branches through aggressive media campaigns and promotions.

E-branch

We began the deployment of electronic channel branches to reduce our carbon footprint and that of our customers by transacting business through electronic means. Transactions such as withdrawals, transfers, balance enquiries, bills payment, voucher vending and cash deposits can be done in these branches. We presently have about 33 e-Branches nationwide.

E-savers

We have incorporated greening into our products development which has led to the launch of accounts like the GTCrea8 e-Savers account for students and the e-Account for salary earners. These Accounts can be operated only through electronic channels.

Diesel Consumption

The Bank has adopted a mandatory 8.00pm generator shut down time in our branches nationwide to reduce the amount of fossil fuel released into the atmosphere. This has gone a long way to reduce our carbon footprint.



Energy Saving Lights

GTBank replaced 70% of all sodium vapour light bulbs with energy saving light bulbs in all its branches which have proven to consume less energy and last longer thus ensuring a safer environment.

- The additional disclosure requirements under the Disclosure and Transparency Rules of the Financial Services Authority United Kingdom.In Guaranty Trust Bank, the ultimate responsibility for the governance of the Bank resides with the Board of Directors which comprises 8 Non-Executive Directors and 6 Executive Directors.

Our Board of Directors exercises an oversight function through various Committees; Board Credit Committee, Board Human Resources & Remuneration Committee and Audit Committee.

The Bank also appointed a Chief Compliance Officer to monitor compliance with the Code of Corporate Governance and provide regular statutory reports to the Central Bank of Nigeria.

DIVERSITY

Guaranty Trust Bank has been a gender equal organization since 1990; well before the Millennium Development Goals for Gender Equality. In 2012, our bank's average staff ratio was 43% female and 57% Male with an ultra modern crèche facility within the head office premises, enabling new mothers visit their babies whilst at work.
